In compliance with section 152.013(c) of the Local Government Code, the Commissioners Court hereby gives notice of salary and allowances for the elected officials of Denton County. Elected officials salaries will be set on Tuesday, September 4, 2018 at 7:00 p.m. as part of the FY2019 budget adoption process. The public meeting will be held at the Denton County Courthouse on the Square, 110 W. Hickory, 2nd Floor in the Commissioners Courtroom, Denton, Texas 76201. * County Salary Supplement - These positions also receive a salary of \$140,000 from the State of Texas.

** Proposed salary amounts included mandated judicial longevity pay for these positions that are statutorily tied to our current District Judge that receives this additional pay from the state. Salary amount includes \$4,340 that has been pro-rated to be effective until 12/31/2018 in the amount of \$1,085 for the Judges of County Criminal Court #2, County Criminal Court #3, and County Criminal Court #4. Salary amount includes \$4,340 for Judge of County Criminal Court #1. These amounts are subject to change based on the current District Judges' Judicial longevity pay.

\$1,500 Juvenile Board Compensation is included for the County Judge, all District Judges, all County Court Judges and the Probate Court Judge.

The County Salary Supplement for the Criminal District Attorney includes a State Salary Supplement of \$3,500 annually plus the cost of related benefits of which will be reimbursed to Denton County by the State.

Annual salaries are a calculation of each officials bi-weekly salary times 26 pay periods. Salaries may be less in some fiscal years and more in others depending on the actual payroll date (October-September).
